PROJECT DESCRIPTION: The Fulton Library Reading Garden will be created on a vacant lot adjacent to the Fulton Road branch of the Cleveland Public Library. The project will include several quiet sitting areas for residents and library patrons to enjoy, either for reading or enjoying the environment. This will be accomplished by building low curved walls buffered by dirt on one side that will inhibit sound and mirror the Library's landscaping design. These walls will only be two and a half feet high as to not impose a safety risk. The reading garden will also include many trees and shrubs throughout and incorporate several pieces of public art.

PROJECT GOALS: The Clark Fulton neighborhood has limited outdoor and recreational spaces for residents to utilize. The goal of this project is to create additional green space and to promote the importance of reading. Creating an outdoor space for residents to interact with each other promotes better community engagement and quality of life. By connecting this space with the Library, it helps advocate the joy of reading and will hopefully attract more people to use their facility.

RELATIONSHIP TO CURRENT REVITALIZATION ACTIVITIES: Fulton Road is a major thoroughfare within the Clark Fulton neighborhood and has been the focus of many revitalization efforts by the Councilman and the CDC over the past several years. In addition to a complete street reconstruction from Clark to Denison, Fulton has seen many distressed properties demolished including the two buildings that were on this site. Several businesses on Fulton have also planned to take advantage of the storefront renovation program within the next year and the Jones Home Historic District, in which these parcels belong, recently became a nationally recognized historic district.

CONTRIBUTION TO IMPROVING HEALTH: In addition to benefits additional trees provide for our physical health, the reading garden will contribute to improving mental health for neighboring residents and patrons of the Library. Increased interaction with the natural environment has been proven to help decrease stress and promotes more physical activity. With the addition of bike lanes now on Fulton road, the reading garden could be a destination for all walks of life.

CONTRIBUTION TO SUSTAINABILITY: The project will include a native species rain garden which will help with storm water retention. Several trees and shrubs will also help reduce run off in addition to reducing surface heat for this area.

ABILITY OF CDC AND PARNTERS TO MAINTAIN THE SITE: The Cleveland Public Library has agreed to maintain the site in conjunction with their Fulton branch.
